WAIVER AND RELEASE OF LIABILITY

In consideration of being allowed to participate in any way in the Hawaiian Canoe Racing Association, Keauhou Canoe Club Heihei Long Distance Race, I, the undersigned, intending to be legally bound hereby for myself, my heirs, executors and administrators, do waive and release any and all rights and claims for damages I may have against Keauhou Canoe Club, Moku O Hawaii Canoe Racing Association and the Hawaiian Canoe Racing Association, and the Trustees of Kamehameha Schools/Bishop Estate.

Agree that prior to participating, I will inspect the facilities and equipment to be used, and if I believe anything is unsafe, I will withdraw from the race and refuse to participate.

- 1. Acknowledge and fully understand that each participant will be engaging in activities that involve risk or serious injury, including permanent disability and death, and severe social and economic losses which might result not only from my own, but also the actions, inactions or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further that there may be other risks not known to me or not reasonably foreseeable at this time.
2. Assume all the foregoing risks and accept personal responsibility for the damages following such injury, permanent disability or death.
3. Release, waive, discharge and covenant not to sue Keauhou Canoe Club, Moku O Hawaii and Hawaiian Canoe Racing Associations, Kamehameha Schools/Bishop Estate, and any affiliated Associations, clubs, their respective administrators, directors, coaches and other volunteers or employees, if any.
4. I also indemnify any and all other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of the premises used to conduct the event, all of which are hereinafter referred to as "releasees", from demands, losses and/or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or part by the negligence of the releasee or otherwise.
